- 1. The Southeast Asia Primary learning Metrics is a regional assessment of grade 5 student's competencies in reading, mathematics, science and global citizenship. Seven countries from SEAMEO have committed to take part in the implementation of SEA PLM.

- 3. The purpose of SEA PLM Field Trial is to test the validity and reliability of the items in the test booklets and questionnaires, and also of the process.

 - School principals will receive questionnaires and stationery for students participating in the survey along with funding provided by UNICEF.
 - The 2-day training workshop was developed based on ACER's training framework with adaptation for relevance to Viet Nam. We are sharing the draft training program sent you to see and give additional comments. Thanks.
